ORDER

In the matter of: CWP No. 7159/2024-titled as Tilak Raj & others Vs. State of HP and others decided on 24.07.2024 by the Hon'ble High Court of H.P.

That the above case was listed for final hearing on 24.07.2024 before the Hon'ble High Court of HP when the same was disposed of by way of passing following judgment. Operative part of the judgment is as under: -

- 1. Taking into consideration the fact that the petitioners have directly approached this Court without firstly making representations to the employer vis-à-vis the relief being claimed in the petition, as prayed for, this writ petition is disposed of by granting liberty to the petitioners to file appropriate representations to the respondent vis-à-vis the issue raised in the present petition.

2. In the event of any such representations being filed within four weeks', let appropriate decision thereupon be taken by the respondent within eight weeks' as from the date of the receipt thereof.

The representation of the petitioners was received in this office wherein they have sought the relief as reproduced below:-

"This representation may kindly be taken into consideration and the applicants may kindly be considered as TGT (Hindi) & TGT (Sanskrit) in all respect and grant them, the pay scale of TGTs from the due date in light of the judgment dated 04.09.2023 passed by the Hon'ble High Court of Himachal Pradesh in CWP NO. 2171/2023, titled as Hem Raj & others V/s State of H.P. and they may kindly also be considered for promotion to the post of PGT/Lecturer (School-New) alongwith other similarly situated persons i.e. TGT (Medical), TGT (Non-Medical) & TGT (Arts)"

Whereas, the case of the petitioner has been examined in compliance to the judgment passed in CWP No. 2171/2023 titled as Hem Raj vs. State of HP & others taking into consideration the Notification of the Governemnent issued vide No. EDC-B(15)15/2011 dated 20-08-2022 which says, "all Bachelor of Education (B.Ed.) qualified and Teacher Eligibility Test (TET) passed Shastris and Language Teachers (LTs) working in the Elementary Education Department are to be designated as Trained Graduate Teachers (Sanskrit) and Trained Graduate Teachers (Hindi) in their respective pay scale structure." Therefore, no financial benefits were granted to these categories, and merely their nomenclature was changed to TGT (Sanskrit) and TGT(Hindi) and that too for only those Shastri/Language Teachers who are B.Ed. qualified and TET pass.

Whereas, consequent upon the change of nomenclature of the post from Shastri/Language Teacher to TGT (Sanskrit/Hindi), Sh. Hem Raj and others filed CWP No. 2171/2023 in the Hon'ble High Court, seeking the pay scale of TGTs and promotional avenues to the post of Lecturer(School Cadre).

Whereas, the Hon'ble High Court in the said CWP No. 2171/2023, vide judgment dated 04-09-2023 (Para 7), has ordered as follows:

"In view of the discussion in para 5 above, these writ petitions are allowed. The respondents are directed to grant the pay secle of the post of Trained Graduate Teachers(TGTs) and promotional avenue to the post of Lecturer(School New) to the petitioners (Shastri (Sanskrit) and Language Teacher (Hindi)- now-redesignated as TGT(Sanskrit) and TGT(Hindi) respectively, in terms of notification dated 20-08-2022, as is being given to TGT(Medical), TGT(Non- Medical), and TGT(Art). This shall be admissible to them from the date of issuance of notification dated 20.08.2022. The exercise be completed within seven weeks from today, miscellaneous applications, if any, also stand disposed of."

It is pertinent to mention here that this judgment of the Hon'ble High Court in the Hem Raj case (CWP No. 2171/2023) has been assailed by the Department by way of filing the LPA No. 86/2024 in the Hon'ble High Court which has been admitted in the Hon'ble High Court. However, the Govt. vide order No.EDN-C-E(5)33/2023 dated 20.05.2024 and 17.09.2024 has considered such re-designated TGTs (Sanskrit/Hindi) to be entitled for promotion as Lectureres/Headmasters with the condition that tenure or service of such re-designated Sanskrit/Hindi Teachers as TGT shall be considered from the date of notification dated 20.08.2022 subject to the final outcome of LPA No. 86/2024 (State Vs Hem Raj).

Thus, after considering the whole matter, such re-designated TGTs (Sanskrit/Hindi) under CWP No.7159/2024 titled as Tilak Raj & others vs. State of HP are entitled to be considered for promotion as Lecturers/Headmasters and thus they are considered for the same subject to final outcome of LPA No. 86/2024. However, tenure or service of such re-designated Sanskrit/Hindi Teachers as TGT shall be considered from the date of their re-designation as TGTs which in this case, is the date of notification dated 20-08-2022. It is pertinent to mention that as per the R&P Rules for the post of Lecturer (School-New) and Headmaster, there is specified period of minimum length of service as TGT (5/8 years) for a candidate to become eligible for promotion. Thus, these teachers shall become eligible for promotion only after completion of required length of service which is to be counted w.e.f. 20.08.2022.

With these observations the representations stands disposed of and the petitioners be informed accordingly.
