- 1. Delivery of the quoted items shall be made by the supplier in accordance with the time scheduled, as per clause "I" above. Any deviation in performance of its delivery obligations shall render the supplier liable to any or all of the following action:
  - a) Forfeiture of its Earnest Money Deposit/Performance Security Deposit,
  - b) Imposition of penalty,
  - c) Debarment for participation in the tender for non supply of particular product for a period of 3 Years. If any Company fails to supply more than three quoted products then the approved supplier shall be debarred for participation in the tenders floated by the Department of Health & Family Welfare, H.P for a period of three years for all items.

- d) Termination of the agreement for default.
- 2. If at any time during the performance of the agreement, the supplier should encounter conditions Impending timely delivery of the goods, the supplier shall promptly notify the purchaser in writing of the facts of the delay and its likely duration and its cause(s). As soon as practicable after receipt of the suppliers notice, the purchaser shall evaluate the situation and may at its discretion extend the suppliers time for performance after seeking prior approval through email from the Director, Health & Family Welfare, H.P.
- 3. The Purchaser shall deduct from the contractor under the provision of Clause 11 &12 penalty/liquidated damages on the items, which the contractor has failed to deliver within the delivery period.

#### N. PENALTIES:

- 1. Subject to clause "I", if the supplier fails to deliver any or all of the goods within the time period(s) specified in the agreement, the purchaser shall without prejudice to its other remedies under the agreement, deduct from the contract price, as liquidated damages a sum equivalent to 2.5% of the delivered price of the delayed goods for each week of delay or part thereof, until actual delivery with maximum of 5 percent, if extension has been granted, otherwise supply order may stand cancelled / terminated after 15 days.
- 2. In the event of making ALTERNATIVE PURCHASE due to non-compliance of L1 bidder due to any reason, penalty will be imposed on the supplier apart from forfeiture of Performance Security Deposit.

Health Procurement Cell, Health & Family Welfare, Shimla-171009 and the concerned Indenting officers(Purchaser) of the District Stores and the price payable for the items to be supplied against the supply order after the date of such reduction in sale price coming in to force, shall stand correspondingly reduced.
- 3. # 1. Rapid Antigen Testing for SARs COV-2

- a) The testing kit should be validated and approved by ICMR or any validation centre that has been approved / certified by ICMR.
- b) The company / authorized supplier should be approved by ICMR and also by Drug Controller General of India (DCGI).
- c) US-FDA approved kits should have the approval of DCGI.

  - v. Manufacturer's instructions for use
- f) Pack Size: 1x25 Tests

# 2. IgG based ELISA testing for conducting sero-survey: -

- a) The ICMR has come out with guidance on 23-06-2020 regarding conducting Sero-Surveys. In this regard it is strictly advised that IgG based ELISA and CLIA assays have to be used. In this regard, the committee is of the opinion and as per the directions of the ICMR(ICMR guidelines dated 23.6.2020 as amended from time to time), IgG based ELISA will be used for the Sero-Surveys. Since the ELISA system is already in place in most of the health care facilities in HP, so the committee recommends the use of IgG based ELISA, instead of the Rapid Anti-body Testing, as is also advised by ICMR.
- b) The Sero Survey only subject to prevailing Govt. guidelines.
- c) Industrial workers or labour force, farmers, vendors visiting large markets, staff in municipal bodies, drivers, banks, post, couriers, telecom offices, shops, Air travel related staff, congregate settings, prisons etc.
