Subject:- Regarding re-engagement/submission of particulars of PTA-GIA TGTs and C&V teachers.

Memo

With reference to the Govt. letter No. EDN-A-Kha(7)6/2012-L dated 19.02.2013 vide which it has been conveyed that the services of all those PTA provided teachers under GIA to PTA Rules 2006 (i.e. 29.06.2006), whose services have been discontinued due to new appointment or by way of transfers, will be re-engaged by the concerned PTAs, who were found eligible by the Committees constituted by the Govt. vide Notification No. EDN-A(kha)7-3/2006 dated 19.4.2008 and dated 27.5.2008 and were eligible as per the R&P Rules at that relevant time. No PTA provided teacher will be re-engaged whose services were terminated by the committees mentioned to above keeping in view the irregularities found in their appointments. The matter of re-engagement of all those PTA provided teachers who have resigned or remained willfully absent will not be considered. Further, it has also been directed to take option(s) of any three stations from the incumbent regular/contract teachers, who had replaced the services of the PTA provided teachers and accordingly they can be transferred further at the place of their choice so that PTAs of the concerned institutions will take the services of the said teachers. However, this may ensure the services of the PTA provided teachers shall take place only after the transfer of the regular/contract teachers and in any case no surplus arrangement is allowed.

Therefore, in continuation to these directions, you are directed to send the entire record pertaining to the PTA-GIA provided TGTs and C&V teachers who have been working as such on 31.12.2007 and were engaged prior to 06.11.2006 as per directions conveyed vide this office letter No. EDN-H(2)B(2) PTA/2006 dated 06.11.2006, covered under PTA-GIA Rule 2006 and whose services were disengaged due to the joining of regular /contract incumbent by way of recruitment /promotion/ transfer, who were found eligible by the Committees constituted by the Govt. vide Notification No. EDN-A(kha)7-3/2006 dated 19.4.2008 and dated 27.5.2008, on the proforma given below alongwith the following documents within prescribed time limit:-

- 1 Order of engagement by the PTA.
- 2 Photo copies of certificate of educational and professional qualification.
- 3 Photo copy of orders of transfer/promotion / appointment due to which the services of PTA-GIA were disengaged.
- 4 Certificate issued by the Principal of the concerned School as per specimen given below:-

Certificate

It is to certify that Sh. /Smt..... was engaged by the Parent Teacher Association of GMS/GHS/GSSS Distt. after observing all the codal formalities as per instructions issued vide Directorate of Hr. Education letter No. EDN-H(8)17(2)46/2006-PTA dated 19.8.2006.

1. Sh. /Smt.was paid Grant in Aid under the Grant in Aid Rules-2006 for the period for which he/she actually worked.
2. The services of Sh./Smt. were disengaged due to the joining of regular/ contract appointee and not due to recommendation made by the Inquiry committee.
3. Enquiry committee had never ever recommended his/her termination.
