Payment of arrears on account of revision of pay scales under the Himachal Pradesh Civil Services (Revised Pay) Rules, 2009.

Sir,

- 1. am directed to invite your attention to Rule 8 of the Himachal Pradesh Civil Services (Revised Pay) Rules, 2009 notified vide Notification of even number dated 26th August, 2009 and to say that the Governor, Himachal Pradesh is pleased to order that an amount up to Rs. 10,000/- (ten thousand) only, out of the pay arrears accrued on account of revision of pay scales, may be paid to the employees in the month of March, 2010 after making necessary adjustments as stated in para 2 below. In case of Government employees whose pay arrears are less than the amount of Rs. 10,000/- (Ten thousand), such employees may be paid the actual arrears. The amount so arrived at may be credited to the General Provident Fund Account of the concerned employees after deducting the Income tax at source, wherever applicable. In case of employees who have retired from Government Service or who have closed their GPF accounts on account of retirement, and in case of the employees who are covered under the Contributory Pension Scheme, the arrears may be paid in cash after deducting the income tax, wherever applicable.
- 2. The amount of Interim Relief already paid vide this Department's O.M. No. Fin (PR) B(7)-2/2006 dated 7.3.2008, 18.10.2008 and 28.1.2009 (also refer Note-7 below Rule-7 of the Himachal Pradesh Civil Services (Revised Pay) Rules, 2009) is required to be adjusted against the

pay arrears. The amount of "Adjustable Emoluments" as mentioned in O.M. Nos. FIN (PR)B(7)-1/2009 dated 9.9.2009 and 12.10.2009 may also be adjusted from the amount of the above said arrear and only the net amount may be paid. In case the amount of pay arrear as stated in Para 1 above is not sufficient to adjust the amount of interim relief already paid and the total "Adjustable Emoluments" and any amount is still to be adjusted, the same shall be adjusted against future release of pay arrears/increase in pay and allowances.

- 3. It shall be the responsibility of the concerned DDO to ensure that the entire amounts are adjusted as stated above at the earliest from the arrears and the balance amount may only be credited to the GPF account of the concerned employee, or paid in cash, as the case may be, as stated at para 1 above.
- 4. In the case of State Government employees, who, during the above said period worked in different Government Departments or PSUs/Boards/ Corporations of the State Government etc., the arrears may be prepared and disbursed by the concerned State Government Department or PSU/Board/ Corporation etc. where such employees are presently working.
