In supersession of this department's office order of even number dated the 5th May, 1987 and as per amendment made in the IAS (Pay) Rules, 1954, vide Government of India, Department of Personnel and Training, New Delhi, Notification No.14021/4/98-AIS-A, dated the 21st December, 1998 substituting the word 'Special Allowance' instead of Special Pay w.e.f.1.8.97 and in terms of the provision of Clause (3) of Rule-9 of the amended Indian Administrative Service (Pay) Rules, 1954, the Governor, Himachal Pradesh, is pleased to sanction enhancement of Special Allowance to IAS Officers in H.P. w.e.f.01-08-97 as under:-

1. IAS Officers in Selection Grade and Junior Administrative Grade (on completion of 9 years of service) except Deputy Commissioners /Additional Deputy Commissioners.	Rs.1000/-p.m.
2. IAS Officers in the Senior Time Scale(except as at Sr. No.3 and 4 below).	Rs. 800/-p.m
3. Deputy Commissioners/Additional Deputy Commissioners.	Rs.600/-p.m.
4. Sub Divisional Officers(Civil)/ AC(Dev.)-cum-BDO.	Rs.400/p.m.

2. The IAS Officers holding ex cadre posts will also draw enhanced Special Allowance w.e.f. 01-08-97 of the respective cadre posts to which the posts held by them have been declared equivalent. The arrear of Special Allowance w.e.f.01-08-97 to 31-03-99 ~~will~~ <sup>would</sup> be credited to the G.P.F. account of the officer concerned and shall be paid in cash from 01.04.99.
