I am directed to invite your attention towads this Department's letter of even number dated the 26% May, 1994, relating to the subject cited above and to state that the rates of grant of deputation(duty) allowance admissible to HP Government employees on deputation, have been revised by the Finance Department w.e.f. 01.04.98. Accordingly, the matter of grant of deputation(duty) allowance to HPAS officers was placed before the Council of Ministers in the meeting held on 26.04.99.

- Accordingly, it has been decided that in future all HPAS officers posted on deputation shall continue to draw in their own pay scale and a Special Allowance of Rs. 800/- PM only and shall not be allowed any deputation(duty) allowance.
- This decision shall be applicable w.e.f. 01.04.98 and all officers presently on deputation whose terms and conditions of deputation stands determined, shall be allowed Rs.800/-PM Special Allowance from this date instead of Rs. 400/-
