## OFFICE MEMORANDUM

Subject: - Clarification regarding Rule-11 of the Himachal Pradesh Civil Services (Revised Pay) Rules, 2009.

The undersigned is directed to refer to Rule 11 of the Himachal Pradesh Civil Services (Revised Pay) Rules, 2009 notified vide notification of even number dated 26<sup>th</sup> August, 2009 which provides the procedure of pay fixation on promotion. It is clarified that the method of fixation of pay on promotion after 1.1.2006 in the revised pay structure shall be as under:

On promotion from one grade to another, a Government servant has an option under FR 22 (1)(a)(1) to get his pay fixed in the higher post either from the date of his promotion, or from the date of his next increment. The pay will be fixed in the following manner in the revised pay structure:-

(i) In case the Government employee opts to get his pay fixed in the higher post from the date of his promotion, the pay of the Government servant shall be fixed in accordance with Rule 11 of the H.P. Civil Services (Revised Pay) Rules, 2009. The next increment in the higher

post shall be granted after completion of qualifying service of twelve months

- In case, the Government servant opts to get his (ii) pay fixed in the higher post from his date of next increment, then, on the date of promotion pay in the pay band shall continue unchanged, but the grade pay of the higher post will be granted Further re-fixation will be done on the date of his next increment. On that day, he will granted two increments. be one annual increment and the second on account of promotion While computing these two increments, basic pay prior to the date of promotion shall be taken into account. To illustrate if the basic pay prior to the date of promotion was Rs.100, first increment would be computed on Rs. 100 and the second on Rs 103
- (iii) The next increment in the higher post in this case will be granted after completion of qualifying service of twelve months from the date of re-fixation.
- (iv) In cases of Government employee, who stand promoted during the period from the 1<sup>st</sup> day of January,2006 to the date of publication of the H.P Civil Services (Revised Pay) Rules,2009,the Government servants may be

 (v) allowed to exercise fresh option, within a period of one month from the date of this clarification, to get their pay fixed on promotional post.
