OFFICE MEMORANDUM

The undersigned is directed to say that the Finance Department has been receiving a number of cases seeking clarification on the following two issues:

- (a) In cases where the next higher pay scale allowed under ACPS and the pay scale of the promotional post are identical, whether the benefit of FR 22(1)(a)(i) should be admissible or not?
- (b) In cases where the initial start of the pay scale of the feeder and promotional post are the same but the end is different, in such a situation whether benefit of FR 22(1)(a)(i) should be admissible on promotion or not?

In the above context, it is clarified as under:

1. For the purposes of release of benefit under FR 22(1)(a)(i), the scale of the feeder as well as promotional posts is relevant and not the placement scale given to an individual under ACPS or allowed as a measure personal to an individual. Therefore, even if the pay scale given under ACPS or that allowed as a measure personal to an individual is same as the scale of the higher post, the movement from one post to another shall be considered a promotion and shall be eligible for benefit under FR 22(1)(a)(i). However, the release of benefit shall be regulated by para-2 (vi) of this department letter No. Fin(PR)B(7)51/98 dated 15.12.1998.

2. In case both the posts: feeder and promotional, have an identical basic minimum scale, the post having higher maximum of the scale shall be considered to be a higher post.


