Clarification regarding date of annual increment on placement as Junior Assistant.

Sir/Madam,

I am directed to invite a reference towards this Department's letter No. Fin(PR)-B(7)-1/2009-LOOSE dated: 7<sup>th</sup> December, 2011, vide which placement of Clerk as Junior Assistant has been restored with effect from 01.01.2006. Certain departments have asked for clarification from this Department with reference to the admissibility of next increment in the event when the Pay in the Pay Band on placement as Junior Assistant is higher to the minimum of relevant Pay Band.

2. In this context, it is clarified that vide instructions referred to above, the placement of Clerk as Junior Assistant has been restored as on 01.01.2006 and bifurcation in the cadre of Clerks in the ratio of 50:50 is to be done as was being done prior to 01.01.2006. Accordingly, the date of increment on placement as Junior Assistant is to be allowed on completion of 12 months from the date of such placement if it is below the minimum of the Pay in the Pay Band of placement pay scale of Junior Assistant. In case, the placement is at a stage equal to or higher than the minimum of the Pay in the Pay Band; the date of annual increment shall remain unchanged.
