OFFICE MEMORANDUM

Subject:-

Restoration of one-third commuted portion of pension in respect of the Government servants who had drawn lump sum amount on their absorption in Public Sector Undertaking/Autonomous Body.

The undersigned is directed to refer to this Department's O.M. of even number dated 4th June, 2005 on the above cited subject vide which the restored amount of 1/3rd commuted portion of pension in respect of absorbees who had drawn lump sum amount on their absorption in Public Sector Undertaking/ Autonomous Bodies was revised. The matter regarding grant of Dearness Relief on full pension and also the merger of 50% Dearness Relief of full pension instead of 1/3rd commuted portion of pension has been considered in the Government.

- 2. Governor, Himachal Pradesh is pleased to decide that such absorbed employees shall, apart from the payment of revised restored amount of 1/3rd commuted portion of pension, be also entitled to the payment of Dearness Relief on full pension from the date of restoration, instead of Dearness Relief on the revised restored amount of 1/3rd commuted portion of pension. In other words, Dearness Relief shall be payable on full pension i.e. the revised pension which the absorbed employee would have received on the date of restoration of 1/3rd commuted portion of pension had he not drawn lump sum payment of absorption. Dearness Relief equal to 50% of full pension would be converted into Dearness Pension instead of 50% Dearness Relief of 1/3rd restored/ revised pension w.e.f. 1-4-2004. Accordingly, Dearness Relief prior to 1-4-2004 would be payable on full pension and with effect from 1-04-2004 on full pension plus Dearness Pension. The payment of Dearness Relief will, however, be subject to the conditions laid down in para-4 of O.M. dated 4th June, 2005.
- 3. Para-3 of O.M. No. Fin (Pen)A(3)-1/97-I dated 4th June, 2005 and para-5 of O.M. No. Fin (Pen)B(10)-6/98-I dated 8-8-2005 shall, therefore, be deemed to have been modified as indicated above.
- 4. The respective Administrative Department, where the absorbed employee was employed prior to absorption, shall forward the cases to Senior

Deputy Accountant General (A&E), Himachal Pradesh, for issue of P.P.O's/Revised P.P.O's.

5. The Pension Disbursing Authorities including authorized Public Sector Banks while making payment under these orders will adjust the amount of Dearness Relief/ arrears of Dearness Relief already paid to the absorbed employees under this department O.M. of even number dated 4th June, 2005 and O.M. No. Fin (Pen)B(10)-6/98-I dated 8-8-2005.
