OFFICE MEMORANDUM

Subject: Grant of Interim Relief to the employees of the Government of Himachal Pradesh.

I am directed to invite a reference to the subject cited above and to state that the Governor of Himachal Pradesh is pleased to grant interim relief of 5% of Pay (including dearness pay) w.e.f. 1.11.2006 to the employees of Himachal Pradesh Government excluding Officers of All India Services. The Interim Relief will be treated as pay for the purposes of payment of Dearness Allowance and retirement benefits only. The amount of Interim Relief will be absorbed in the future pay revision to be allowed by the State Government.

The arrears payable on account of payment of Interim Relief upto 29.2.2008 may be credited to the GPF accounts of the employees. Interim Relief arrears of employees who have retired may be paid in cash. Interim Relief payment w.e.f. 1.3.2008 may be disbursed in cash.

These orders will be applicable to the employees working in the Himachal Pradesh Government. As far as PSUs/Universities/Boards/Autonomous Bodies are concerned, the managements of these PSUs/Universities/ Boards/Autonomous Bodies etc. will take necessary action in the matter after taking into consideration the resources position of the concerned PSUs/Universities/Boards/Autonomous Bodies etc.
