**OFFICE MEMORANDUM**

**Subject:** **Clarification on payment of arrear accrued on account of release of Dearness Allowance @ 6% w.e.f. 01.01.2009 and 5% w.e.f. 01.07.2009 on the revised pay structure.**

This refers to this Department's OM No. Fin-(C)B(7)-2/2006 dated 26<sup>th</sup> August, 2009 and 22<sup>nd</sup> September, 2009 whereby additional instalment of Dearness Allowance @ 6% and 5% respectively, of Basic Pay were released in favour of the regular employees of the State Government who have opted for Revised Pay Scales and arrear accrued on this account was ordered to be paid in cash after making appropriate adjustments. It is hereby clarified that the arrears accrued upto 31.08.2009 on account of release of additional instalments of Dearness Allowance w.e.f 01.01.2009 and 01.07.2009 @ 6% and 5% respectively, may be paid in cash without making any adjustments. The appropriate adjustment as ordered vide OM dated 26<sup>th</sup> August, 2009 may be made against pay arrears to be released in due course of time.

2. It is reiterated that the salary as per the revised pay scales from 1.9.2009 will include the Dearness Allowance component of 27% and in case the total emoluments in the old pay scales of an employee exceeds the total emoluments admissible after fixation of pay in the Revised Pay Structure and there happens to be "ADJUSTABLE EMOLUMENT" as brought out in O.M. No. Fin(PR)-B(7)-1/2009, dated 9<sup>th</sup> September, 2009, the same will be set off at the earliest in any future increase in emoluments of the concerned employee, whether by way of increment earned, future release of



**Dearness Allowance, payment of arrears of any kind, promotional increments etc.**

3. These orders shall apply to only those regular employees / officers whose pay has been fixed in the revised pay structure in terms of Himachal Pradesh Civil Services (Revised Pay) Rules, 2009.
