## OFFICE MEMORANDUM

Subject: - Grant of Dearness Allowance to the employees of the State Government w.e.f. 01.01.2003.

In continuation to this Department's Office Memorandum of even number dated 26<sup>th</sup>, December, 2002, the Governor, Himachal Pradesh is pleased to or ier that the Dearness Allowance payable to the employees of the Government of Himachal Pradesh shall be enhanced from the existing rate of 52 % to 55 % of pay w.e.f. 1st January, 2003

- The term "PAY" for the purpose of calculation of Dearness Allov ance, shall remain the same as defined in para 2 of this Department O.M. No. Fin(C)-B(7)-3/98 dated 27th May, 1999 and in respect of such employees who have opted to retain pre-revised pay scales or whose scales have not yet been revised, the term "Ay" shall be the same as defined in para 2 and note below para 2 of this Department O.M. No. Fin(C)-B(7)-3/98 dated 8th November, 1999.
- 3. The admissible Dearness Allowance shall be paid in cash w.e. 1.10.2003 and the arrears accrued from 01.01.2003 to 30.09.2003 shall be credite to it e General Provident Fund Accounts of the employees and interest thereon shall rue from 01-11-2003. The entire credited amount will be held back for one year. The Government employees, who have retired or have closed their GPF Accounts, shall be paid the arrears in each.

In case of such Government employees who are not eligible to subscribe to the provident Fund, the drawal of arrear shall be deferred till Provient Fund / ccount is opened in his / her name OR the arrears may be paid through purchase of National Small Savings Certificates of an amount equal to the nearest \$.100/- and the balance amount may be paid in cash. The option of waiting till a CP account is available of purchase of NSS certificates may be given to such employees.

- The Dearness Allowance will continue to be a distinct element of remuneration 5. and will not be treated as pay.
- The payment on account of Dearness Allowance involving fract on of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
- These orders are applicable to regular and work-charged employees of the State Government.
