Department's Office In continuation to this Memorandum of even number dated oth January, 1998, the Governor, Himachal Pradesh is pleased to order that the rates of the Dearness Allowance payable to the employees of the Government 06 Himachal Pradesh shall stand modified as under: Rate of Dearness Allowance per mentem Date from which payable

32% of pay.

The term "PAY" for the purpose of calculation of Dearness Allowance, shall be the pay drawn in the revised scales pay, including stagnation increment(s) and non practicing allowence, but shall not include any other type(s) of pay like special ply or all employees

The admissible Dearness allowance to personal pay, etc. shall be paid in cash w.e.f. 1.6.1999 and the arrears accrued from 1st January, 1999 to 31st May, 1999 General Provident Accounts of the employees concerned during the month of June, 1999 and the interest on the contribution so made to the G.P.F. shall accrue from 1st July, 1999. The entire cledited amount would not be withdrawn for a period of three years.

during the said period, not eligible to subscribe to the Provident Find, the drawal of arrears of Dearness Allowance shall be deferred till the employee concerned becomes eligible to contribute to Provident Fund In such a and the Provident Fund Account is opened in his/her name. case, as and when the Provident Fund Account is opened and the amount of arrear of Dearness Allowance is credited thereto, interest who have will accrue from 1st July, 1999. The Government employees. retired or have closed their General Provident Fund Accounts before the issue of this Office Memorandum or who might close their



Accounts by the time the arrears are arown, shall be seem arrears in cash.

- 5. As regards the employees of State Government Undertakings/Boards/Corporations etc., the Governing Body/Board of Directors of the concerned Institution will sanction the instalement of Dearness Allowance w.e.f. 1.1.1999 on the pattern and conditions applicable to the State Government employees.
- 6. The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as Pas
- 7. The payment on account of Dearness Allwance involving fraction of 50 paisa and above may be rounded off to the next higher rupes and the fraction of less than 50 paisa may be ignored.
- 8. These orders are also applicable to the Work-charged employees.
- 9. These orders with regard to sanction of Dearness Allowance will not be applicable to the Staff pair from contingencies, Casual labour, staff employed on daily wages and those working on piece-rate-system. These orders will also not be applicable to those employed on contract basis except where Dearness Allowance is admissible in term of their contract.
- 10. Orders in respect of employees who have opted to retain the pre-revised pay scales or whose scales have not been revised including employees who are governed by the U.G.C. scales will be issued separately.
