Sir,

I am directed to say that the question of determining the terms and conditions in respect of sitting Members of the Legislative Assembly on their appointment as Chairman / Vice Chairman of Government Public Sector Undertakings / Autonomous Bodies has been under consideration of the Government. The Governor, Himachal Pradesh is now pleased to order that the Members of the Legislative Assembly on their appointment by the Government as Chairman / Vice Chairman of any Public Sector undertakings / Autonomous Bodies shall be deemed to have been assigned additional charge of the office of...

the Himachal Pradesh Vidhan Sabha in accordance with the provisions of the Himachal Pradesh Legislative Assembly (Allowances and Pension of Members) Act,

in addition to the facilities in accordance with the H.P. Legislative Assembly (Allowances and Pensions of Members) Act, 1971, such members shall be entitled to the following facilities for holding the additional assignment as

Chairman / Vice Chairman:-

1. Free telephone facility, one in the office and one at the residence will be provided by the concerned undertaking (Telephone facility at the residence is to be provided if no telephone is provided by the Vidhan Sabha in the residential accommodation provided by the Vidhan Sabha.
2. Secretarial Assistance in the shape of personal staff will be provided by the undertaking.
3. Reimbursement of actual electricity and water charges at the residence minus Rs. 300/- per month will be borne by the concerned undertaking.
4. One vehicle alongwith the services of a driver out of the sanctioned pool will be provided by the concerned organisation.
5. A sum of Rs. 800/- P.M. shall be paid by the concerned undertaking as symptuary allowance.
6. T.A./ D.A. as also the Road Mileage Allowance (while on tour in own vehicle) shall be borne by the concerned organisation at the rates as per entitlement as member of Legislative Assembly for touring in connection with the affairs of concerned bill will, however,

require countersignature by Secretary, H.P. Vidhan Sabha. The concerned Members shall be their own Controlling Officers for claim of T.A. / D.A. as Chairman / Vice Chairman.


7. The accommodation provided by H.P. Vidhan Sabha to the M.L.As. appointed as Chairman / Vice Chairman will be semi - furnished by the concerned organisation.

These orders shall be applicable w.e.f. 17/ 10/ 1996 onwards. in the case of Hon'ble Members appointed as Chairman / Vice Chairman of Public Sector Undertakings prior to 17/ 10/ 1996, all facilities as per entitlement of M.L.A. under the H.P. Legislative Assembly (Allowances and Pension of Members) Act, 1971 shall be payable by the concerned organisation in addition to the facilities indicated at sl. no. 1 to 6 above for the period from 1/8/1996 to 16/10/1996, provided that no facilities have been availed by any such member from H.P. Vidhan Sabha during this period.

I am to request that the terms and conditions in respect of the M.L.As appointed as Chairman / Vice Chairman of Public Sector Undertakings / Autonomous Bodies may be prescribed in accordance with the above guidelines.



the subject mentioned above and to say that the Governor,
Himachal Pradesh, in supersession of above orders, is pleased
to order that the following terms and conditions will govern
the appointment of sitting M.L.As. as Chairman / Vice
Chairman of various Public Sector Undertakings / Autonomous
Bodies etc. in Himachal Pradesh :-

1. Free telephone facility, one in office and one
at the residence will be provided by the concerned
Undertaking (telephone facility at the residence is to be
provided if no telephone is provided by the Vidhan Sabha in
the residential accommodation provided by the Vidhan Sabha.)

Provided that the difference between the
actual telephone charges and the telephone allowance
admissible under the H P

and Pension of Members) Act, 1971 in respect of the telephone provided by the H.P. Vidhan Sabha shall be reimbursed by the concerned Undertaking.

2. Secretarial assistance in the shape of Personal Staff will be provided by the PSU.

3. Reimbursement of actual electricity and water charges at the residence minus Rs. 500/- P.M. will be borne by the concerned Undertaking.

4. One Vehicle alongwith the services of a Driver out of the sanctioned pool will be provided by the concerned Organisation.

5. A sum of Rs. 800/- P.M. shall be paid by the concerned Undertaking as Sumptuary Allowance. In case they are appointed in the rank of Minister, they shall be paid Rs.1000/- as Sumptuary Allowance.

6. T.A./D.A. as also the road mileage allowance (while on tour in own vehicle) shall be borne by the concerned organisation at the rates as per entitlement as member of Legislative Assembly for touring in connection with the affairs of concerned organisation. T.A. bill will, however, require countersignature by the Secretary, H.P. Vidhan Sabha. The concerned members shall be their own controlling Officers for claim of T.A./D.A. as Chairman/Vice-Chairman.

7. The accommodation provided by the H.P. Vidhan Sabha to the MLA's appointed as Chairman/Vice-Chairman shall be semi-furnished by the concerned Organisation.


8. In the case of Public Sector Undertakings/Autonomous Bodies having headquarter outside Shimla, the Chairman/Vice-Chairman shall be entitled for rent free semi-furnished accommodation at such headquarter to be provided by the such Organisation or Rs. 2500/- per month as House Rent in lieu thereof.

On their appointment as Chairman / Vice Chairman , as the case may be, they shall be deemed to have been assigned the additional charge of the office of

Chairman/ Vice Chairman and they shall be entitled to all facilities from the H.P. Vidhan Sabha in accordance with the provisions of the Himachal Pradesh Legislative Assembly (Allowances and Pension of Members) Act, 1971, in addition to above facilities.

All Administrative Departments are requested to prescribe the terms and conditions of sitting MLAs on their appointment as Chairman / Vice Chairman of the Public Sector Undertakings / Autonomous Bodies etc. in accordance with the above guidelines.


