## OFFICE MEMORANDUM

Subject:

Grant of Deputation (Duty) Allowance to H.P. Government employees.

. . . . .

The undersigned is directed to say that at present the amount of Deputation (Duty) Allowance is regulated by the provisions contained in paras 4.1 and 6 of the Government of India's orders bearing No. 2/12/87-Estt.(Pay-II),dated 29/4/1988, which were adopted vide this Department's letter No. Fin (C) B (12)- 1/91, dated of the 26th August, 1991. Consequent upon revision of pay scales of the State Government employees, the matter relating to revision in the rates of Deputation (Duty) Allowance was under consideration of the State Government and the Governor, H.P. is pleased to decide the following rates of deputation allowance:

(a) 5% of the basic pay of employee subject to a maximum of Rs.500/- per month when the transfer is within the same station; and

- (b) 10% of the basic pay of employee subject to a maximum of Rs. 1000/- per month in all other cases.
- 2. The Deputation (Duty) Allowance shall be further restricted as under :-
- (i) Pay + Deputation(Duty) Allowance shall not exceed the maximum of the scale of pay of the ex-cadre post; and
- (ii)Pay + Deputation (Duty) Allowance shall at no time exceed Rs. 22100/- per month.
- The Governor, Himachal Pradesh is also pleased to decide that the restriction under F.R. 35 mentioned in para- 1 of this Department's letter dated 26/8/1991 shall be as under:-
- (a) For employees in receipt of basic pay upto Rs.8000/p.m.

15% of the basic pay subject to a maximum of Rs. 1000/- p.m.

(b) For employees in receipt of basic bay above Rs.8000/p.m.

12 1/2% of the basic pay subject to a maximum of Rs.1000/- p.m.

5. These orders shall take effect from 1st April 1998. The cases of deputationists prior to this date shall governed by the orders dated 26/8/1991.
