
SUBJECT:- DEPUTATION / SECONDMENT OF GOVERNMENT SERVANTS TO PUBLIC SECTOR UNDERTAKINGS / AUTONOMOUS BODIES / COOPERATIVE INSTITUTIONS ETC. - RECOVERY OF LEAVE SALARY AND PENSION CONTRIBUTION THEREOF.

The undersigned is directed to invite a reference to this department's letter of even number dated 17th May, 2004 on the subject noted above and to say that vide letter under reference, it was decided to realize leave salary & pension contribution in cases of deputation secondment of State Government employees to the public sector undertakings / autonomous bodies / cooperative institutions etc. under the control of State Government.

However, in most of the PSUs / autonomous bodies etc., officers of various organized cadre services like HAS, HPS, HPFS, SAS etc. are required to be posted keeping in view the provisions of relevant Acts, statutes and Articles of Association of concerned PSU/ autonomous body etc.. As most of the PSUs or autonomous bodies are controlled & funded by the State Government, there will be indirect burden on the State Government as a result of decision of state government dated 17th May, 2004. In addition, it will also create accounting problems.

Keeping above facts in view, it has been decided by the State Government that the decision contained in this department's O.M. of even number dated 17th May, 2004 will not be applicable in such cases where services / posting of cadre service officers / other employees are required in a Public Sector Undertaking / Autonomous Body / Board etc. which is wholly or substantially controlled by the State Government of Himachal Pradesh in terms of provisions of any Act / statutes or by laws of

concerned Public Sector Undertaking / Autonomous Body / Board etc.. This decision may kindly be brought to the notice of all concerned under your control.


