OFFICE MEMORANDUM

SUBJECT: DEPUTATION / SECONDMENT OF GOVERNMENT SERVANTS TO PUBLIC SECTOR UNDERTAKINGS / AUTONOMOUS BODIES / COOPERATIVE INSTITUTIONS ETC. ----- RECOVERY OF LEAVE SALARY AND PENSION CONTRIBUTION THEREOF.

The undersigned is directed to invite a reference to this Department's O.M. of even number dated 17th May, 2004 on the subject mentioned above and to say that orders for realization of leave salary / pension contribution in cases of deputation / secondment of H.P. Government employees to Public Sector Undertakings/ Autonomous Bodies / Cooperative Institutions etc. under the control of State Government were issued vide above O.M. Subsequently, vide O.M. of even number dated 11th December, 2006, it was clarified that the provisions of O.M. dated 17th May, 2004 will not be applicable in such cases where services / postings of cadre service officers / other employees are required in a public sector undertaking / autonomous body / board etc. which is wholly or substantially controlled by the State Government of Himachal Pradesh, in terms of provisions of any Act / Statutes or bye-laws of concerned PSU/ Autonomous Body / Board etc.

Matter relating to realization of leave salary / pension contribution in case of such State Government employees who are sent to BBMB was under consideration of the State Government for some time past. After examination of the matter and keeping in view the fact that BBMB is a joint venture between Govt. of India, Govt. of H.P. and some other Governments and employees from different states are posted & sent to BBMB on transfer / placement basis, it has been decided that the provisions of O.M. dated 17th May, 2004 will not also be applicable in cases of

employees of State Government whose services are placed at disposal of BBMB on transfer basis. Above decision may be brought to notice of all concerned.


