In continuation of this department's letter of even number dated 25th September, 2001 and Department of Personnel O.M.No.8-17/73-DP(AP-II), dated 28 June, 2001 on the subject cited above, I am directed to say that some departments are referring the cases for clarification to F.D. on the issue of "Secondment" in respect of extension in deputation period etc. The matter has been considered and the following clarifications /guidelines are issued to the notice of all concerns:-

- 1. The post failing vacant in the lending departments on account of Secondment will not be filled up by any mode of recruitment including even on officiating/temporary basis;
  - 2. After the issuance of instructions dated 28.6.2001, no appointment will be made on deputation basis, it will be only by transfer on "Secondment basis" and no deputation allowance will be admissible to the incumbents. The departments will review all such cases where the deputation allowance allowed has been allowed even after issuance of instructions dated 28.6.2001.
