He was promoted on regular basis to the post carrying duties and responsibilities of higher nature carrying Pay Band of ₹15600-39100+₹ 6000 Grade Pay w. e. f. 01.03.2012. What is his substantive pay i.e. Band Pay and Grade Pay, on the basis of which he will get total salary for the month of April payable on 1st May, 2015? (20)
- Q. No. 7 What are the Fundamental Principles for guidance of authorities authorized to enter into contracts involving expenditure from public funds? (20)

- (a) Mr. 'A', died while in service on 12.11.2014. He was survived by his wife and two sons. Wife died on 24.01.2015. Eldest son Mr. 'X' born on 10.06.90 is unmarried & physically disabled to the extent that he is unable to earn his livelihood. Youngest son Mr. 'Y' born on 29.08.1992 is also unmarried but got appointed as clerk in Government of H.P., On 16.12.2014. State how Family Pension is/will be paid to each family member.
- (b) Mr.'X', a Senior Assistant availed himself of pre-sanctioned EL for 30 days from 10.4.2007 to 9.5.2007. He superannuated on 31.1.2015. At the time of retirement he had 190 days EL and 200 days HPL at his credit. He applied for commutation of leave for 20 days on 5.1.2015 duly supported with a medical certificate. How will you regulate his request for commutation of leave from EL to HPL on medical grounds?
- (c) Wife and nominee of a subscriber to GPF remarried before the receipt of Provident Fund money of her late husband. Head of Office disqualified her from receiving the payment of GPF balance of the subscriber, stating that the nomination made by the subscriber is Null and Void consequent on her remarriage. Comment on the action of the Head of Office.
- (d) Pay and Allowances are ordinarily payable on the 1st of next month except for the month of March when the same are generally payable on the last day of the month. What are the circumstances when pay and allowances can be paid before the pay day?
