- 4. It must be ensured that the candidate is not specially abled.
- It must beensured that the candidate is not on the verge of retirement.
- 6. All provisions as contained in O/M No: PER (AP-3)E(3)17/2021 dated10.07.2013"Comprehensive guiding principles 2013 -----for regulating the transfer of State Govt. Employee at point no.5" consession to certain categories of employees and 5.5 of O/M dated 17.09.2015 must be adhered strictly.

The Principals / Headmasters as mentioned above with the directions that the incumbent working under your establishment be relieved immediately(except if the school under reference is affected by Model Code of Conduct due to Panchayati Raj elections) failing which disciplinary action will be initiated against the defaulter under the rules.
