Whereas, Sh. Munish Kumar, TGT (NM) preferred CWP No. 9357/2023 titled as Munish Kumar, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS Bhogra, Distt. Shimla to nearby home station in Distt. Kangra. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 28-11-2023 when the Hon'ble High Court has passed the following orders:-

"10. Accordingly, the impugned order dted 10.10.2023 (Annexure P-3), is quashed and set-aside with the direction to Respondent No.2-Director of Elementary Education, Himachal Pradesh, to re-examine the representation dated 17.09.2023 (Annexyre P-2) and to pass a fresh consideration order, in light of the above discussion, within two weeks from today, after giving personal hearing to the petitioner."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 04-01-2024. He attended the same and submitted her representation in this office on 04-01-2024, vide which he has requested that he has completed required tenure at his present place of posting and he further requested that he may be transferred to nearby home station in Distt. Kangra, against vacancy/longer stayee, being couple case.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Bhogra, Distt. Shimla w.e.f. 22-02-2021 and has almost completed three years stay at present place of posting. One Sh. Sandeep Kumar TGT(NM) is working in GSSS Nandrool, Distt. Kangra since 10-01-2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GHS Bhogra, Distt. Shimla to GSSS Nandrool, Distt. Kangra, vice Sh. Sandeep Kumar, TGT(NM) by clubbing his previous stay, with TTA/JT to Sh. Sandeep Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
