In this context, please find the list alongwith recommendations/ applications in original as received from the concerned candidate as well as through Employment exchanges directly with the directions that the interview as per requisitions ibid, may be conducted in your district. The Selection Committee will be same as already constituted vide this office letter of even No. dated 26.10.2013.


You are hereby directed to start the process of interview w.e.f. 20.10.2015 on the same guidelines/conditions as intimated earlier on 26.10.2013. Also advertise the dates of interview in the local news papers to the knowledge of aspirants so as to avoid any legal complications. Consolidated award list of candidates in original as well as in Pen Drive along with their Bio-Data may be submitted to this Directorate through special messenger who is well conversant with the matter on or before 20th November 2015.

It is further informed that the Ward of Ex-serviceman certificate issued from the Sainik Welfare Authority of Himachal Pradesh, affidavits (as per Annexure-A & Annexure-B specimen copies enclosed) may be invited through call letter from each candidate at the time of interview.

You are also apprised that in one of the decision passed by the Hon'ble High Court in CWP No. 2958 of 2009, the Hon'ble High Court has quashed the letter of the Govt. dated 22.2.2003. We may mention that as per Govt. letter dated 22.02.2003 "the married daughters cannot be considered as dependent on Ex-serviceman for Employment against the quota reserved for Ex-service-men". However, as per approval of the Govt. conveyed on dated 22.07.2015 LPA is being filed against this order.

In-view of above married daughters may also be considered for interview against ward of ex-servicemen subject to final out-come of LPA. The concerned Deputy Directors are directed to invite the names of married daughters from the concerned Employment exchanges and also consider the direct applications for the purpose **with the condition that it will depend on the final outcome of LPA.**
