It is, therefore, requested to provide following information in detail:-

1. How many PTA provided teachers (under PTA to GIA Rules 2006), who have been taken over on contract basis? The category wise information be provided.
2. Number of PTA provided teachers (under GIA to PTA Rules 2006) are yet to be taken over? The category wise information be provided with detail reasons.
3. No. of PTA provided teachers (under PTA to GIA Rules 2006) who are not considered for taking over their services due to strike break. No. of teachers, who have more than 42 days break.
4. No. of teachers (under PTA to GIA Rules 2006) whose services were discontinued by the inquiry committees constituted by the Government and whose have been re-engaged either by the inquiry committees or by the Hon'ble Courts. List with break period be provided.
5. No. of PTA provided teachers (under PTA to GIA Rules 2006) whose services were discontinued due to the joining of the government teachers and who have been re-engaged by the Courts. List with break period be provided.
6. No. of PTA provided teachers (under PTA to GIA Rules 2006) who have been re-engaged after 1.1.2013 by the Government. List with break period be provided.

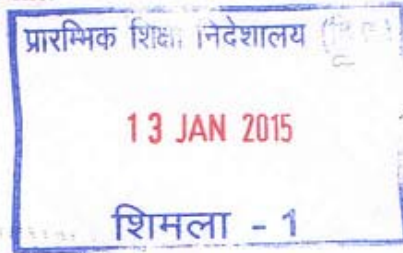
