Note - While implementing above transfers of teachers the norms and standards for providing teachers in a school as contained under Sr. No. 1(a) in the schedule of RTE Act 2009 be complied strictly. In case, any violation of these instructions you will be entirely responsible. These orders be implemented in relaxation of ban on transfer.

- 1. In case of Condonation of short stay willingness of the concern incumbent may be obtained first.
- 2. Willingness of the concerned teacher be obtained by the incharge/Head of the institution before relieving him/her, in case he/she is not willing for the transfer, then he/she may not be relieved and the case may be referred back alongwith his/her unwillingness in r/o mutual transfers.
- 3. If the incumbent has already served sub-cadre/hard/tribal/difficult area in that event he/she not relieved again to areas ibid.
- 4. It must be ensured that the candidate is not specially abled.
- 5. It must beensured that the candidate is not on the verge of retirement.
