Shimla and he further requested that he may be transferred to nearby home station in Distt. Hamirpur, H.P against vacancy/ longer stayee by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Bahgal, Distt. Shimla, H.P w.e.f. 14-03-2019 and has completed the normal tenure of three years. One Sh. Kamal Singh, TGT(NM) is working in GHS Baliah, Distt. Hamirpur, H.P since 28-07-2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms.. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GSSS Bahgal, Distt. Shimla to GHS Baliah, Distt. Hamirpur, H.P, vice Sh. Kamal Singh, TGT(NM), by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Kamal Singh, TGT(NM). The representation of the petitioner is disposed of accordingly.
