

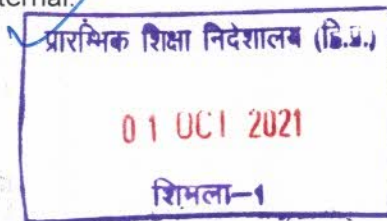

2. Incase of condonation of short stay willingness of the concerned incumbent may be obtained first.
