Sh. Ram Pal, TGT (NM) preferred CWP No. 3482/2023 titled as Ram Pal TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS Kaffota, Distt. Sirmour, H.P to Distt. Kangra, against vacancy. "5. 6. Needless to say that order shall be passed after giving the personal hearing to petitioner, if desired so. .".

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 24-07-2023. He attended the same and submitted his representation in this office on 24-07-2023 vide which he is serving since 14-03-2019 in GSSS Kaffota, Distt. Sirmour, and he further requested that he may be transferred to Distt. Kangra against vacancy. He has given five stations of his choice in the aforesaid representation.

From perusal of record, it has been found that the petitioner, is working in GSSS Kaffota, Distt. Sirmour since 14-03-2019 and has completed more than three years stay at present place of posting. One post of TGT(NM) is lying vacant in GHS Draman, Distt. Kangra, H.P. and (22) students are studying in this school. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby transferred on his own request from GSSS Kaffota, Distt. Sirmour to GHS Draman, Distt. Kangra, H.P against vacancy being caused due to promotion of present incumbent as Headmaster. The representation of the petitioner is disposed of accordingly.
