In case such representation is preferred, same shall be decided by the competent authority on or before 25<sup>th</sup> July, 2023, by passing a speaking and resoned order, after affording opportunity of personal hearing to the petitioner, if desired so. Order shall be communicated to the petitioner immediately thereafter. In case, station(s) mentioned in the representation is/are lying vacant, then at least, one of such stations shall not be filled, if not already filled, till the decidion of representation."

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 22-07-2023. He attended the same and submitted his representation in this office on 22-07-2023 vide which he is serving since 07-09-2018 in GMS Bounch, U/C GSSS Koti Bounch, Distt. Sirmour (Sub cadre) and he further requested that he may be transferred to Distt. Kangra and Distt. Una, H.P against vacancy. He has given five stations of his choice in the aforesaid representation.

From perusal of record, it has been found that the petitioner is working in GMS Bounch, U/C GSSS Koti Bounch, Distt. Sirmour (Sub cadre) since 07-09-2018 and has completed more than three years stay at present place of posting. However, stations of his choice are not vacant at this stage and also there is no person who has completed his normal tenure. Therefore, after careful examination, it is decided that since the Department of Higher Education is going to make promotions to the post of School Lecturer (New) from amongst the eligible Trained Graduate Teachers in near future, hence the petitioner will be given posting at a suitable place as and when the vacancy will arise at his place of choice. The representation of the petitioner is disposed of accordingly.
