Till such time, the petitioner shall not be compelled to join at the transferred station and she may avail leave of the kind due. However, the protection available to the petitioner in this order shall atand automatically vacated, in case the representation is not preferred by her within the indicated time line. Pending miscellaneous application(s), if any, shall also stand disposed of."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner has submitted her representation and requested that She may be transfer/adjusted in the stations nearby her native place in Distt. Una, H.P, against vacancy/longer stayee. The petitioner is mother of one year old child.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Gondpur Banehra, Distt. Una, w.e.f. year 2019 and under transfer to GSSS Shawga, Distt Sirmour, H.P. At present there is no post of TGT(NM) lying vacant in schools given by the petitioner in her representation. One Sh. Joginder Pal, TGT(NM) is working in GSSS Kanger, Distt. Una, H.P since 02-06-2011 and has completed his tenure of (12) years at his present place of posting. The petitioner has requested in her representation that She may be transferred/adjusted at GSSS Kanger, Distt. Una against longer stayee. Keeping in view of the above position, the representation of the petitioner is considered sympathetically and She is hereby transferred/adjusted at GSSS Kanger, Distt. Una, vice Sh. Joginder Pal, TGT(NM) with TTA/JT to Sh. Joginder Pal, TGT(NM). The representation of the petitioner is disposed of accordingly.
