ORDER

Sh. Akshdeep Thakur, TGT (Arts) has filed CWP No. 6153/2023-before the Hon'ble High Court of H.P., regarding transfer from GMS Shashan u/c GSSS Solang, District Shimla. The case was listed on 06-09-2023, when the same has been disposed of with the following orders:-

"In view of above submission, this writ petition is disposed of by directing respondent No. 2 competent authority to decide the aforesaid representations of the petitioner dated 09-05-2023 (Annexure P-2) in accordance with law and applicable Policy, within a period of three weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Akshdeep Thakur, TGT (Arts) has submitted fresh representation, wherein he stated that he has completed normal tenure at his present place of posting and has requested for transfer from GMS Shashan u/c GSSS Solang, District Shimla to GSSS Saliana or GHS Rajnali, District Kangra, against vacancy, due to retirement of present incumbent on 30-09-2023.

From the perusal of record, it is found that Sh. Akshdeep Thakur, TGT (Arts) is working at GMS Shashan u/c GSSS Solang, Diistrict Shimla since 22-02-2017 and has completed normal tenure at his present place of posting. One post of TGT (Arts) is going to be vacant at GSSS Saliana, District Kangra, being caused due to retirement of present incumbent on 30-09-2023. Keeping in view the position stated above, representation of petitioner i.e Sh. Akshdeep Thakur, TGT (Arts) is considered sympathetically and he is hereby transferred from GMS Shashan u/c GSSS 'Solang, District Shimla to GSSS Saliana, District Kangra, against vacancy without TTA/JT, being caused due to retirement of present incumbent on 30-09-2023. The representation of the petitioner is disposed of accordingly.
