Sh. Ajay Kumar, TGT (NM) preferred CWP No. 4620/2023 titled as Ajay Kumar, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his repatriation from BRCC Upper Primary, E/B Bijhari, Distt. Hamirpur to near by his native place, against vacancy. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 19-07-2023 when the Hon'ble High Court has passed the following orders:-

"The pleadings in the case show that ever since the year 2008, petitioner is serving in District Hamirpur. In these circumstances, no interference with the impugned order is called for in exercise of jurisdiction under Article 226 of the Constitution of India. However, taking into consideration the averments made in the petition, this writ petition is disposed of by permitting the petitioner to file a representation to respondent No.2/competent authority within two days from today. In case, such representation is filed, the same shall be considered by respondent No.2/competent authority in accordance with law and applicable transfer policy & guidelines, within a further period of one week. The decision so taken shall also be communicated to the petitioner."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation and requested that he may be transferred/adjusted in the stations nearby his native place against vacancy. The petitioner has also requested to transfer him at GMS Nand Nagraon, U/C GSSS Jhandutta, Distt. Bilaspur, against vacancy.

From perusal of record, it has been found that the petitioner is working as BRCC Upper Primary, Education Block Bijhari, Distt. Hamirpur and under order of repatriation to GMS Riya, Distt. Solan, H.P. The Petitioner is going to be retired on 31<sup>st</sup>. December, 2024, which is about 17 months remaining of completion. The post of TGT (NM) is lying vacant in GMS Nand Nagraon, U/B GSSS Jhandutta, Distt. Bilaspur, H.P. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby further adjusted on his own request at GMS Nand Nagraon, U/B GSSS Jhandutta, Distt. Bilaspur, H.P against vacancy being caused due to promotion of present incumbent as Headmaster. The representation of the petitioner is disposed of accordingly.
