Further it is also decided by the Government vide notification No.PER(AP.B) B(15)-5/2014 dated 25.04.2017 that "interview process will not imply viva-voce or evaluating the personality of the incumbent. The selection of class-III posts shall be made on the basis of prescribed Educational qualification followed by evaluation, by verifying the original documents/credentials only based on the parameters devised in the notification of even No. dated 17.04.2017. Detail is as under:-



In view of above, it is directed to start the counseling w.e.f 09.04.2018 and complete the process latest by 1<sup>st</sup> May 2018 strictly as per above criteria as well as provisions contained in the R&P Rules. Award List must contain above parameters only. While sending call letters the above parameters may also be incorporated as well as in the bio-data forms at the time of counseling. Weightage for the minimum educational qualification should be taken only of B.Ed.. The award list of the eligible candidates must be deposited on or before 15.05.2018 through dealing hand or superintendent of the concerned district in original alongwith a soft copy.

**Note:- Candidature of the married daughter of Ex. Service Men and candidature of the married daughter/grand daughter of Freedom Fighter is subject to final outcome of LPA No. 215/2015 titled as Jyoti Kumari and others pending before the Hon'ble High Court of Himachal Pradesh and SLP No. 31435/2016 titled as State of H.P. & Others versus Neelam Kumari pending before the Hon'ble Supreme Court of India.**
