## ORDER

In the matter of:

CWP No. 4260/2023-titled as Dimpal Raj, TGT (Arts) V/s State of Himachal Pradesh (Regarding Transfer).

Sh. Dimpal Raj, TGT (Arts) has filed CWP No. 4260/2023 titled as Dimpal Raj V/s State of H.P., regarding transfer from GMS Baggi u/c GSSS Kupvi, District Shimla. The case was listed before the Hon'ble High Court of H.P. on 11-09-2023, when the same has been disposed of with the following orders:-

"In view of the above submission, this writ petition is disposed of by directing the respondents/competent authority to decide the representation of the petitioner dated 10-05-2023 (Annexure P-3) within three weeks from today in accordance with law and applicable policy. The decision so arrived at shallbe communicated to the petioner. Pending miscellaneous applications(s), if any, also to stand disposed of."


In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Dimpal Raj, TGT (Arts) has submitted representation (Annexure P-3), wherein he stated that he has completed normal tenure in present place of posting and has requested for transfer from GMS Baggi u/c GSSS Kupvi District Shimla to GHS Leda u/c GSSS Gurkotha, GHS Jhor u/c GSSS Kapahi, GSSS Kanaid, GSSS Hatgarh District Mandi or GSSS Jejwin District Bilaspur, against vacancy. As per fresh representation received from petitioner he has requested to transfer/adjustment at GSSS Bagla, District Mandi, against vacancy, due to retirement of present incumbent on 30-09-2023.

From the perusal of record, it is found that Sh. Dimpal Raj, TGT (Arts) is working at GMS Baggi u/c GSSS Kupvi, District Shimla since 21-01-2019 and has completed normal tenure at his present place of posting. At present post of TGT (Arts) are not lying vacant in the above mentioned schools. Keeping in view the position stated above, representation of petitioner i.e Sh. Dimpal Raj, TGT (Arts) can not be considered at this stage due to non vacancy and the transfer will affect the study of students in the mid session. Hence, request made by the petitioner is hereby rejected and disposed of accordingly.
