"ORDER"

The CWP No. 6359/2023 titled as Kamlesh Kumar V/s State of H.P. was listed in the Hon'ble High Court of H.P. on 13.09.2023 when the Hon'ble Court dismissed the same with the direction for the petitioner to represent to the competent authority projecting his difficulties and for the competent authority to decide the same in accordance with law and applicable transfer policy.

As per the representation of the petitioner Shri Kamlesh Kumar, JBT who is presently under orders of transfer from GPS Bandokhi to GPS Kahla District Chamba submitted to the undersigned on 15.09.2023, transfer proposal was sought from the Deputy Director of Elementary Education, Chamba, District Chamba. On perusal of comments/proposal submitted by the concerned DDEE on 29.09.2023, it reveals that the petitioner Shri Kamlesh Kumar, JBT was transferred from GPS Bandokhi to GPS Kahla against vacancy with the prior approval of competent authority. Sh. Kamlesh Kumar, JBT who has been working at GPS Bandokhi since 06.02.2014 and has completed his normal tenure in the said school. The petitioner has sought his transfer against vacant post at GPS Anoga or GPS Seri or GPS Pantah or GPS Tiyari or GPS Manjhali Education Block Sundla, against vacancy. The DDEE Chamba has further intimated that at present GPS Kahla Education Block Sundla is running with single teacher school & enrolment is 15 and out of two sanctioned posts, only one teacher working.


In view of above facts, the representation of the petitioner is examined after due consideration. As the petitioner has completed his normal stay at present place of posting and the GPS Kahla (Sundla) is running with single teacher school and his transfer orders to GPS Kahla (Sundla) shall stand.
