## **ORDER**

In the matter of:

CWP No. 6172/2023-titled as Sohan Singh, TGT (Arts) V/s State of Himachal Pradesh (Regarding Transfer).

Sh. Sohan Singh, TGT (Arts) has filed CWP No. 6172/2023 titled as Sohan Singh V/s State of H.P., regarding adjustment who is under orders of transfer GHS Kinder District Mandi to GSSS Gumma (Chopal) District Shimla. The case was listed on 06-09-2023, when the same has been disposed of with the following order:-

"At this stage, learned counsel for the petitioner sought permission toithdraw the present writ petition as the petitioner intended tp move representation to the competent authority. The petition is accordingly dismissed as withdrawn. Pending miscellaneous application(s), if any also to stand disposed of."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Sohan Singh, TGT (Arts) has submitted fresh representation, wherein he stated that that he may be adjusted at GMS Ghar u/c GSSS Nihari, GMS Bhalan u/c GSSS Behli, GSSS Khaira, GHS Sahaj u/c GSSS Jassal, GHS Majhagan, against vacancy.

From the perusal of record, it is found that Sh. Sohan Singh, TGT (Arts) was transferred from GHS Kinder u/c GSSS Behli, District Mandi to GSSS Gumma (Chopal) District Shimla, against vacancy, with TTA/JT after completion of normal tenure with the approval of competent authority, where he was working since October, 2006 (PTA) and August, 2020 (Regular) and has completed his normal tenure at his present place of posting. The petitioner has been serving within his home District from last sixteen years, despite the fact that TGT (Arts) is State Cadre post and the incumbents are supposed to serve anywhere in the State in the exigencies of the service.

Keeping in view the position stated above, representation made by the petitioner i.e Sh. Sohan Singh, TGT (Arts) can not be considered at this stage. Hence, request made by the petitioner is hereby rejected and disposed of accordingly.
