ORDER

Sh. Madan Singh, TGT (Arts) has filed CWP No. 5102/2023 in the Hon'ble High Court of Himachal Pradesh, seeking the relief to the extent that the petitioner may be transferred from GHS Bara Bhangal u/c GMSSS Bir District Kangra. The case was listed before the Hon'ble High Court of H.P. on 04-08-2023, when the same has been disposed of with the following orders:-

"In view of above submissions, the instant writ petition is disposed of by permitting the petitioner to make afresh representation to the competent authority/respondents within a week from today, who shall in turn, consider and decide the same, in accordance with law and applicable Transier Policy, within a further period of three weeks by passing a reasoned order, which shall also be communicated to the petitioner. Pending miscellaneous applications(s), if any, shall also stand disposed of."

In compliance to the Hon'ble High Court of Himachal Pradesh, the petitioner Sh. Madan Singh, TGT (Arts) was called for personal hearing and appeared before the undersigned on 13-10-2023. On this day, petitioner has submitted his fresh representation and stated that he has completed normal tenure at his present place of posting and has requested for transfer from GHS Bara Bhangal u/c GMSSS Bir, District Kangra either to GMS Bara Gaon u/c GSSS Kothi Kohar, GSSS Lanoud, GHS Bahi, GSSS Paprola, District Kangra or GSSS Ahju, District Mandi, against vacancy, due to his adverse family circumstances.

From the perusal of record, it is found that Sh. Madan Singh, TGT (Arts) is working at GHS Bara Bhangal u/c GMSSS Bir, District Kangra since 11-01-2019 and has completed normal tenure at his present place of posting. At present the transfer of the petitioner will affect the study of students in the mid session, hence the representation of petitioner Sh. Madan Singh, TGT (Arts) cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected and disposed of accordingly
