In compliance of the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation vide which he has requested that he has completed required tenure at his present place of posting at GHS Fancha, U/C GSSS Ganvi 15/20, Distt. Shimla, H.P and he further requested that he may be transferred to GMS Rosso, U/C GSSS Sadhot, distt. Mandi, GSSS Bhota, GSSS Bohani, Distt. Hamirpur, GSSS Sadhot, GMS Darpa, GSSS Marhi, GSSS Khanot, Distt. Mandi, against vacancy/longer stayee.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Fancha, U/C GSSS Ganvi 15/20, Distt. Shimla difficult/hard area w.e.f. 27-10-2020 and has completed the normal tenure of three years and entitled for his transfer to the station of his choice as per policy. One Shri Nathu Ram, TGT(NM) working in GSSS Marhi, Distt. Mandi since 26-04-2016 and has completed more than (7) years stay there. The petitioner has given willingness for his transfer to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GHS Fancha, U/C GSSS Ganvi 15/20, Distt. Shimlato GSSS Marhi, Distt. Mandi, vice Sh.Nathu Ram, TGT(NM) & vice-versa, with TTA/JT to Shri Nathu Ram, TGT(NM). The representation of the petitioner is disposed of accordingly.
