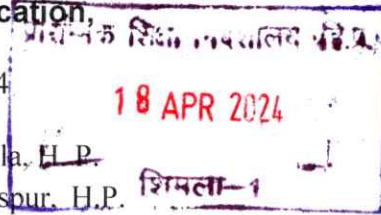

In the matter of: CWP No. 1349/2024 -titled as Jyoti Prakash Suman Vs. State of H.P. & Others.

Whereas, Sh. Jyoti Prakash Suman, TGT (NM) preferred CWP No. 1349/2024 titled as Jyoti Prakash Suman, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Thachadhar, U/C GSSS Gadagusain, Distt. Mandi, H.P to nearby home station in Distt. Mandi. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 28-02-2024 when the Hon'ble High Court has passed the following orders:-

"8. Accordingly, this Court permits the petitioner to make a fresh representation to Respondent No. 2- Director Elementary Education, H.P., Shimla, in continuation of the earlier representation dated 06-02-2024, within a week from today; with further directions th the aforesaid respondent to consider/examine the representation,, in the light of Clauses 12,15 and 16.1 of the transfer policy and to pass appropriate orders within four weeks thereafter. In the aforesaid terms, the writ petition as well as the pending miscellaneous application(s), if any, shall also stands disposed of, accordingly."

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 06-04-2024. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting i.e GMS Thachadhar, U/C GSSS Gadagusain, Distt. Mandi, H.P and he may be transferred to nearby home station in Distt. Mandi, H.P against vacancy/ longer stayee by clubbing his/her previous stay .

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Thachadhar, U/C GSSS Gadagusain, Distt. Mandi, H.P w.e.f. 23-08-2021 and has completed two winters and three summers at his present place of posting. The said school falls in difficult/remote area. One Sh. Anil Kumar, TGT( NM) is working in GHS Sulpur Bhai, Distt. Mandi, H.P since 28-07-2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GMS Thachadhar, U/C GSSS Gadagusain, Distt. Mandi, to GHS Sulpur Bhai, Distt. Mandi, H.P, vice Sh. Anil Kumar, TGT(NM), by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Anil Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.

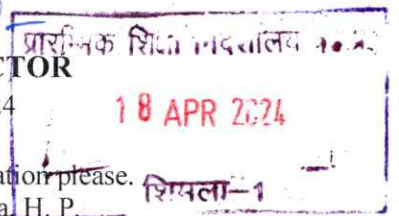

**ORDER**

In the matter of: CWP No: 2439/2024- Raksha Devi Vs. State of Himachal Pradesh.

Smt. Raksha Devi, TGT (Arts) has filed CWP No. 2439/2024 titled as Raksha Devi TGT (Arts) seeking her transfer from GBSSS, Jubbal District Shimla to GSSS, Samtana Kalan Distt. Hamirpur against vacancy, likely to be created due to retirement of present incumbent working there on 30.04.2024 or GSSS, Dhangota Diistt (Hmr.)/GHS Nahlwin Distt. (Hmr.), GSSS, Jhiralri Distt. (Hmr.) against longer stay. She is seeking her transfer on the ground of couple case. The case was decided before the Hon'ble High Court of H.P. on 21-03-2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under :-

*This writ petition is accordingly disposed of with the direction that representations filed by the petitioner be decided in light of the averments made therein with a period of four weeks from today. Pending miscellaneous application(s), if any also stand disposed of accordingly.*

From perusal of the record it is revealed that the petitioner was initially appointed as TGT (Arts) on 20.02.2021 and posted at GBSSS Jubbal, District Shimla. She has completed her normal tenure of three years there. Her husband is serving as Principal in GSSS, Jhiralri Distt. Hamirpur.

*As per provisions contained in Para 5.4 of Office Memorandum No: Per (AP-B) (B) (7)-1/2010-Vol-II dated 17.9.2015 Comprehensive Guiding Principles 2013-for regulating transfers of officers/officials of the State Government dated 10.7.2013 in case wife and husband both are working under the State Government efforts should be made to post them at one place or near places as far as possible subject to vacancy.*

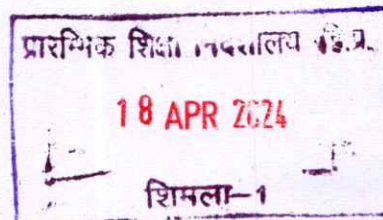
Keeping in view the above said provision of transfer Policy, the representation of the petitioner is considered sympathetically and she is hereby transferred from GBSSS, Jubbal District Shimla to GSSS, Samtana Kalan Distt. Hamirpur against vacancy likely to be created due to retirement of present incumbent on 30.04.2024 without TTA/JT. Incumbent will join after 30.04.2024. With these observations the representation of the petitioner is disposed of. All the concerned be intimated accordingly.

**ORDER**

In the matter of: CWP No: 2030/2024-titled as Sunil Kumar V/s State of Himachal Pradesh (Regarding Transfer).

Sh. Sunil Kumar, TGT (Arts) has filed CWP No. 2030/2024 titled as Sunil Kumar V/s State of H.P. in the Hon'ble High Court, as he is u/t from GMS, Ballu Kharyala u/c GSSS, Bhager Distt. Bilaspur to GSSS Narkanda Distt (Sml.) against vacancy, and now seeking his adjustment at GMS, Randhara u/c GSSS Baha Distt. Solan/ GSSS, Bhageri Distt. Solan/ GMS, Sherpur u/c GSSS, Gunagughat Distt. (Sln.). The case was decided before the Hon'ble High Court of H.P. on 15.03.2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under :-

*"Mr. P.K Verma, learned counsel for the petitioner, under instructions, seeks permission to withdrawn the instant petition with liberty to file representation to the competent authority i.e. respondent No.2.*

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Sunil Kumar, TGT (Arts) has submitted fresh representation and requested to adjust him at GMS, Randhala u/c GSSS, Baha Distt. Solan H.P. against vacancy due to his adverse family circumstances.

From the perusal of record, it is found that Sh. Sunil Kumar, TGT (Arts) is under transfer from GMS, Ballu Kharyala u/c GSSS, Bhager Distt. Bilaspur to GSSS, Narkanda Distt. Shimla against vacancy, with TTA/JT by clubbing his previous stay. At present one post of TGT (Arts) is lying vacant in GMS, Randhala u/c GSSS, Baha Distt. Solan

Keeping in view the position stated above, representation of the petitioner i.e Sh. Sunil Kumar, TGT (Arts) is considered sympathetically and petitioner is hereby adjusted at GMS, Randhala u/c GSSS, Baha Distt. Solan without TTA/JT. The representation of the petitioner is disposed of accordingly.
