CWP No. 1454/2024 titled as Naresh Kumar, TGT (NM) Vs. State of H.P.

Whereas, Sh. Naresh Kumar, TGT (NM) preferred CWP No. 1454/2024 titled as Naresh Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Guwan District Chamba to the station nearby his native place Distt. Kangra, against vacancy/ longer Stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 04.03.2024 when the Hon'ble High Court has passed the following orders:-

"6. In this view of the matter, the petitioner is permitted to submit a fresh representation to respondent No. 2 within one week from today by providing all details as are required under the terms of transfer policy. On receipt of such representation of the petitioner, respondent No. 2 shall consider and decide the same strictly in terms of Clause 16.1 of "Comprehensive Guiding Principles, 2013" by passing a reasoned and detailed order within three weeks thereafter.

Petition is accordingly disposed of, so also the pending miscellaneous applications, if any."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 04.04.2024. He has attended the same and submitted his representation in this office on 04.04.2024 vide which he has requested that he has completed required tenure at his present place of posting i.e GSSS Guwan District Chamba, H.P and he further requested that he may be transferred to Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay. Petitioner has given five stations of his choice in District Kangra.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Guwan District Chamba w.e.f. 24.02.2021 and has completed three years at present place of posting. One Sh. Rajeshwar Kandoria TGT (NM) is working in GMS Talara u/c GSSS Ganoh, Distt. Kangra since 14.12.2021. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GSSS Guwan District Chamba to GMS Talara u/c GSSS Ganoh, Distt. Kangra, vice Sh. Rajeshwar Kandoria, TGT (NM) against longer stay by clubbing his previous stay within radius of 30 Kms with TTA/JT to Sh. Rajeshwar Kandoria, TGT (NM). The representation of the petitioner is disposed of accordingly.
