ORDER

In the matter of CWP No. 7776/2023-titled as Pawan Kumar & others Vs. State of HP and others.

The subject cited case was listed before the Hon'ble High Court on 18.10.2023 and the same was disposed of. Operative part of the judgment is reproduced as under:-

- 3. Accordingly, the petition is disposed of without making any comments on the merits of the case of the petitioners. It is directed that respondents shall consider the case of the petitioners in light of judgment passed by a coordinate Bench of this Court in CWP No. 2171 of 2023 along with connected matters, titled as Hem Raj vs. State of H.P., & Ors., on 4th September, 2023, within eight weeks from today and will decide the same by passing a speaking order. In case, the petitioners are found similarly situated as petitioners in CWP No. 2171 of 2023 along with connected matters, titled as Hem Raj vs. State of H.P., & Ors., on 4th September, 2023, they will also be granted the same benefits as granted to petitioners in above referred case.
- 4. Pending miscellaneous application(s), if any, also stand disposed of. Since the Hon'ble High Court has directed to decide the case on the analogy of CWP No. 2171/2023 titled as Hem Raj Vs. State of HP. But the department has filed LPA before Hon'ble High Court of HP in CWP No. 2171/2023 titled as Hem Raj Vs State of HP and others which is pending for adjudication. Hence, the further action in the present case can only be taken after the final outcome of the LPA filed by the respondent department in the above referred case. With these observations inform the petitioners accordingly.
