ORDER.

In the matter : CWP No.2391/2024 titled as Mangla Dhiman,TGT(Med) VS State of H.P. & others.

The Petitioner,Smt. Mangla Dhiman,TGT(Med)) filed CWP No. 2391/2024 titled as, Smt. Mangla Dhiman,TGT(Med) Vs State of H.P. before the Hon'ble High Court of H.P.regarding her transfer from GSSS Goshaini Distt. Kullu after the completion of required tenure.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 21st March.2024, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

" Learned Counsel for the petitioner submits that the petitioner has filed a representation dated 29-09-2023(Annexure P-2) with the respondent-Department and this petition be disposed of by directing the competent authority to take appropriate decision thereupon within some time bond period.

This writ petition is accordingly disposed of with the direction that the representation filed by the petitioner be decided in light of the averments made therein within a period of four weeks from today.Pending miscellaneous application (s) if any also stad disposed of accordingly."

As per direction of the Hon'ble High Court the petitioner was called for personel hearing on dated. 19th April,2024.The petitioner attended the personal hearing on scheduled date and time. During personal hearing she has requestec that she may be adjusted in GSSS Nabahi/GSSS Hawani/GSS Tikri Sidhwani/GMSSS Baldwara /GSSS Kot Hatli / GSSS Bagra Galu Distt. Mandi against longer stay by clubbing previous stay. The petitioner has further stated that her husband working as Assistant Manager at Jahu Hamirpur in Bank.As such there is no one of the family to look after the oid and ailing father and two minor scn .

From the perusal of the record,it reveals that Smt.Mangla Dhiman ,TGT (Med) is presently working in GSSS Goshaini Distt. Kullu and has completed her normal tenure at present place.Hence,the representation of the petitioner is considered sympathetically and she is herby transferred to GSSS Hawani Distt. Mandi vice Sh. Vijay Kumar,TGT(Med) (by clubbing his previous stay),with TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly.
