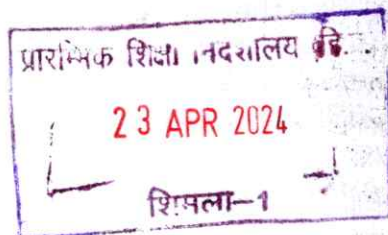

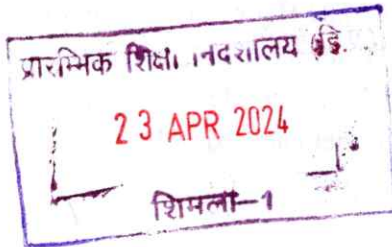

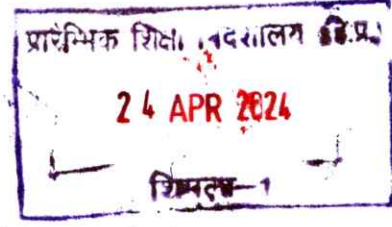

**ORDER**

In the matter of : CWP No. 492 of 2024 titled as Manohar Lal Sharma and others vs. State of H.P. and others decided on 11.01.2024 by the Hon'ble High Court of H.P.

That the above case was listed for final hearing on 11.01.2024 when the same was disposed of with the following orders-

- “2. *Since in the case at hand, a writ of mandamus is being sought, therefore, in the facts and attending circumstances of the case, it was incumbent upon the petitioners to have first approached the respondent/authority for redressal of their grievance, which is being sought in the present petition.*
3. *Faced with the aforesaid, learned counsel for the petitioners seeks permission to withdraw the present petition with liberty to approach the concerned authority by making an appropriate representation.*
4. *Permission granted. Liberty reserved.”*

That all the petitioners have submitted representations in this office as well as to the Secretary (Education) H.P. thereby claiming the relief to the extent that the directions be issued to the respondent authorities to grant pay scale of TGT (Arts) to the applicants alongwith all consequential benefits including arrears in view of the ratio laid down by this Hon'ble High Court vide judgment dated 04.09.2023 in CWP No. 2171/2023 titled as Hem Raj Vs. State of H.P. & others and since the petitioner is TGT consider the petitioner for promotion to the post of Lecturere (School New) like other similar situate persons i.e TGT(Medical), TGT(Non Medical) & TGT(Arts) in view of the ratio laid down by the Hon'ble Court in judgment dated 13.1.2012 passed in LPA No. 102/2010, titled as Dr. Lekh Raj Sharma Vs. State of H.P. and another and any other benevolence benefit amount in favour of the applicant alongwith interest.

That it is submitted that perusal of the record reveals that the petitioners are claiming promotion to the post of Lecturer (School-New) and promotions to the post of Lecturer falls in the domain of Director of Higher Education. The Director Higher Education has not been impleaded as necessary party in this case. The case of the petitioners is not same and similar to the petitioners in the relied upon judgment. The petitioner in the relied upon judgment i.e. Dr. Lekh Raj was being paid identical scale at par with TGT and he was promoted to the post of Lecturer Sanskrit. But as is evident from the bare perusal of the record, the petitioners in these matters are serving as Language Teacher and Shastris from their initial appointment in the pay scale of their respective posts. They were designated by the Government as TGT (Hindi) and

TGT (Sanskrit) vide notification dated 20.8.2022 in their own pay scales and they have not been allowed the scale of TGTs. Hence, they are not entitled for promotions to the post of Lecturer on the analogy of petitioner in the relied upon judgment.

In view of the above discussion the claim of the present petitioners for promotion to the post of Lecturer (School-New) is hereby rejected after due consideration.

That furthermore, since the department has filed LPA before Hon'ble High Court of HP in CWP No. 2171/2023 titled as Hem Raj Vs State of HP and others which is pending for adjudication. Hence, the further action regarding to grant pay scale of TGT (Hindi) and TGT (Sanskrit) may only be taken after the final outcome of the LPA filed by the respondent department in the above referred case. With these observations inform the petitioners accordingly.
