Whereas, Sh. Amit Kumar, TGT (NM) preferred CWP No. 1710/2024 titled as Amit Kumar, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Dhabrain, U/C GSSS Sach, Distt. Chamba, H.P. to nearby home station in Distt. Kangra. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 07-03-2024 when the Hon'ble High Court has passed the following orders:-

"4. Prayer being innocuous is not opposed. Clause 5.4 of the Comprehensive Guiding Principles-2013 provides a concession to an employee of the State Government to be posted at or near the place of the posting of his/her spouse in case such spouse is also employed under the State Government. Keeping in view the prayer on behalf of the petitioner, this petition is disposed of by directing respondent No. 2 to consider and decide the representations of the petitioner Annexure P-1 and P-4 within three weeks from the date of production of this order before him, by passing a detailed and reasoned order. Pending applications, if any, also stand disposed of."

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 05-04-2024. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting i.e GMS Chamba, H.P and he may be transferred to nearby home station in Distt. Kangra, H.P against vacancy/ longer stayee by clubbing his/her previous stay.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Dhabrain, U/C GSSS Sach, Distt. Chamba, H.P w.e.f. 12-07-2019, and has completed the normal tenure of three years at present place of posting. One Smt. Kusam TGT(NM) is working in GSSS Sidhbari, Distt. Kangra, Distt. Kangra, H.P since 26-07-2021. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GMS Dhabrain u/c GSSS Sach, Distt. Chamba to GSSS Sidhbari, Distt. Kangra, vice Smt. Kusam, TGT(NM), against longer stay by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Smt. Kusam, TGT(NM). The representation of the petitioner is disposed of accordingly.
