ORDER

In the matter of: CWP No. 3286/2024-titled as Rashpal Singh V/s State of Himachal Pradesh and others (Regarding Transfer).

Sh. Rashpal Singh, TGT (Arts) has filed CWP No. 3286/2024 titled as Rashpal Singh V/s State of H.P. in the Hon'ble High Court, and seeking his transfer from GMS, Chauhan u/c GSSS, Railla Distt. (Cba.) (Sub-Cadre) District Chamba either to GSSS, Giora (Kgr.) GMS, Damoh u/c GSSS Minjarn Distt (Kgr.), GSSS, Tatwali (Kgr.), GMS Dasoli u/c Raja Ka Talab and GSSS, Maladi distt. (Kgr.) against vacancy. The case was listed before the Hon'ble High Court of H.P. on 23.04.2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Accrdingly, the petition is disposed of with permission to the petitioner to submit a fresh representation to respondent No.2 within one week from today. On receipt of such representation, respondent No.2 shall consider and decide the same within two weeks thereafter, strictly in terms of the "Comprehensive Guiding Principles-2013" for transfer of State Government employees."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Rashpal Singh, TGT (Arts) has attended the personal hearing on 07.05.2024 and stated that he has completed normal tenure at his present place of posting in Sub cadre area and has requested for transfer either to GSSS, Giora (Kgr.) GMS, Damoh u/c GSSS Minjarn Distt (Kgr.), GSSS, Tatwali (Kgr.), GMS Dasoli u/c Raja Ka Talab and GSSS, Maladi distt. (Kgr.) against vacancy.

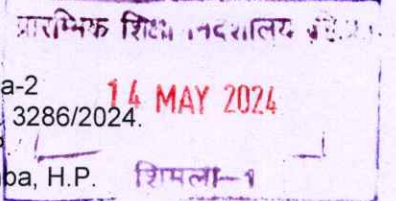
From the perusal of record, it is found that Sh. Rashpal Singh, TGT (Arts) is working at GMS, Chauhan u/c GSSS, Railla Distt. Chamba (Sub-cadre) since February 2021 and has completed normal tenure at his present place of posting. At present the posts of TGT (Arts) is lying vacant in the GSSS, Giora Distt. Kangra.

Keeping in view the position stated above, representation of the petitioner i.e Sh. Rashpal Singh, TGT (Arts) is considered sympathetically and petitioner is hereby transferred from GMS, Chauhan u/c GSSS, Railla Distt. Chamba to GSSS, Giora Distt. Kangra against vacancy. The representation of the petitioner is disposed of accordingly.
