Whereas, Smt. Pooja Sharma, TGT (NM) preferred Ex. Pet. No. 240/2024 in CWP No. 6932/2023 titled as Pooja Sharma, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding her transfer from GHS Jaar Drabil, Distt. Sirmour, to Distt. Una. The above Ex. petition was listed before the Hon'ble High Court, Himachal Pradesh on 02.04.2024 when the Hon'ble High Court has passed the following orders:-

*"Consequently, in view of the fair statement made by learned Additional Advocate General representing the respondent, this Court sees no reason to keep the present petition alive and as such, same is accordingly disposed of with the direction to the respondents to do the needful in terms of judgment dated 27.09.2023 passed by this Court, positively within a period of four weeks, if not already done, failing which, petitioner would be at liberty to get the present proceedings revived, so that appropriate action, in accordance with law, is taken towards implementation of the judgment/order, sought to be executed in the instant proceedings."*

The CWP No. 6932/2023 titled as Pooja Sharma V/s State was decided by the Department on 04.10.2023 it is decided that since the Department of Higher Education is going to make promotions to the post of School Lecturer (New) from amongst the eligible Trained Graduate Teachers in near future, hence the petitioner will be given posting at a suitable place as and when the vacancy arises.

Now, the petitioner has again submitted her representation and requested that she may be transferred from GHS Jaar Drabil, Distt. Sirmour to nearby her native place in Distt. Una, H.P, against vacancy/longer stay by clubbing his previous stay within radius of 30 Kms.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Jaar Drabil, Distt. Sirmour, H.P w.e.f. 18-02-2021, and has completed the normal tenure of three years at present place of posting. One Sh. Rajeev Kumar, TGT(NM) is working in GSSS Kuthar Kalan, Distt. Una. H.P since 02-08-2021. The petitioner has given willingness for her transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and She is hereby transferred without TTA from GHS Jaar Drabil, Distt. Sirmour to GSSS Kuthar Kalan, Distt. Una, H.P. vice Sh. Rajeev Kumar TGT(NM), against longer stay by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Rajeev Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.

Whereas, Smt. Kanchan Bala, TGT (NM) preferred CWP No. 3162/2024 titled as Kanchan Bala, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding her transfer from GSSS Karyali, Distt. Shimla to any of the vacant post near her home station. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 19-04-2024 when the Hon'ble High Court has passed the following orders:-
