Whereas, Sh. Rakesh Kumar, TGT (NM) preferred CWP No. 2600/2024 titled as Rakesh Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Charew u/c GSSS Kaffota District Sirmour to the station nearby his native place Distt. Kangra, against vacancy/ longer stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 04.04.2024 when the Hon'ble High Court has passed the following orders:-

"3. The Petitioner has not been able to make out a case for interference by this Court. Accordingly, the petition is dismissed. However, the petitioner is at liberty to pursue his representation already moved before respondent No 2. Pending application(s), if any, also stands disposed of accordingly.

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 07.05.2024. He has attended the same and submitted his representation in this office on 07.05.2024 vide which he has requested that he has completed normal tenure at his present place of posting i.e GMS Charew u/c GSSS Kaffota District Sirmour, H.P and he further requested that he may be transferred to Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay. Petitioner has given five stations of his choice in District Kangra.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Charew u/c GSSS Kaffota District Sirmour w.e.f. 23.02.2021 and has completed three years at present place of posting. One Sh. Ajay Singh Rana TGT (NM) is working in GSSS Rajiana Bandh, Distt. Kangra since 10.01.2021, The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GMS Charew u/c GSSS Kaffota District Sirmour to GSSS Rajiana Bandh, Distt. Kangra, vice Sh. Ajay Singh Rana, TGT (NM) against longer stay by clubbing his previous stay within radius of 30 Kms. with TTA/JT to Sh. Ajay Singh Rana, TGT (NM). The representation of the petitioner is disposed of accordingly.
