Whereas, Sh. Sudarshan Singh, TGT (NM) preferred CWP No. 2618/2024 titled as Sudarshan Singh Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Godhra u/c GSSS Sahala District Chamba to the station nearby his native place Distt. Kangra, against vacancy/ longer stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 28.03.2024 when the Hon'ble High Court has passed the following orders:-

"5. Accordingly, the instant petition is disposed of with a direction to respondent No. 2 to consider and decide the representation, Annexure P-2, submitted by the petitioner within three weeks from the date of production of copy of this order. Pending applications also stand disposed of."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 07.05.2024. He has attended the same and submitted his representation in this office on 07.05.2024 vide which he has requested that he has completed normal tenure at his present place of posting i.e GMS Godhra u/c GSSS Sahala, Distt. Chamba, H.P and he further requested that he may be transferred to Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay. Petitioner has given five stations of his choice in District Kangra.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Godhra u/c GSSS Sahala, Distt. Chamba w.e.f. 12.07.2018 and has completed normal tenure at his present place of posting. One Sh. Rajan Kumar TGT (NM) is working in GMS Pandhu u/c GSSS Badanj, Distt. Kangra since 12.09.2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GMS Godhra u/c GSSS Sahala, Distt. Chamba to GMS Pandhu u/c GSSS Badanj, Distt. Kangra, vice Sh. Rajan Kumar, TGT (NM) against longer stay by clubbing his previous stay within radius of 30 Kms with TTA/JT to Sh. Rajan Kumar, TGT (NM). The representation of the petitioner is disposed of accordingly.
