Whereas, Kusum, TGT (NM) preferred CWP No. 4354/2024 titled as Kusum, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding her transfer from GHS Sidhbari, Distt. Kangra, H.P to GMS Dhabrain u/c GSSS Sach, Distt. Chamba, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 20.05.2024, when the Hon'ble High Court has passed the following orders:-

"3. At the request of learned counsel for the petitioner, petitioner is permitted to submit her representation to respondent No. 2 within two days from today, detailing therein all the instances of her individual hardship. On receipt of such representation, the same shall be decided by respondent No. 2 within one week thereafter, by passing a detailed and reasoned order.

- 4. Accordingly, the peririon is dismissed as withdrawn.
- 5. Pending miscellaneous application(s), if any, shall also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner has submitted her representation in this office on 21.05.2024, vide which she has requested that she may be transferred/adjusted at GMS Karahpura u/c GSSS Dhaloon, Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay. The petitioner has further stated that she has permanently disabled to the extent of 45%. (Locomotor Disability on account of Rheumatoid Arthritis with bilateral hip implant)

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Sidhbari, Dist. Kangra, and under orders of transfer to GMS Dhabrain u/c GSSS Sach, Distt. Chamba, H.P. One Sh. Brij Pankaj Dixit, TGT(NM) is working in GMS Karakpura U/c GSSS Dhaloon, Distt. Kangra, H.P since 29.06.2021. The petitioner has given willingness for her transfer/adjustment to the aforesaid school against longer stayee by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and She is hereby transferred/adjusted without TTA from GMS Dhabrain u/c GSSS Sach, Distt. Chamba to GMS Karahpura u/c GSSS Dhaloon, Distt. Kangra, H.P. vice Sh. Brij Pankaj Dixit TGT(NM), against longer stayee by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Brij Pankaj Dixit, TGT(NM). The representation of the petitioner is disposed of accordingly.
