ORDER

In the matter of: CWP No. 2084/2024-titled as Rakesh Kumar, TGT (Arts) V/s State of Himachal Pradesh and others (Regarding Transfer).

Sh. Rakesh Kumar, TGT (Arts) has filed CWP No. 2084/2024 titled as Rakesh Kumar V/s State of H.P. in the Hon'ble High Court, and seeking his transfer from GSSS, Cheuni Distt. Mandi (Difficult area) either to GMS, Alathu u/c GSSS, Pairi Distt. Mandi and GSSS, Salwana Distt. Mandi against vacancy. The case was listed before the Hon'ble High Court of H.P. on 16.03.2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"By taking the statement of learned Additional Advocate let representation filed by the petitioner, for his transfer from the present place of posting to one of the stations mentioned in the representation, be decided within a period of four weeks from today and if possible, the petitioner be adjusted at a station of his choice, mentioned by him in the representation, if vacancy is available.

The petition stands disposed of in above terms, so also pending miscellaneous application(s), if any."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Rakesh Kumar, TGT (Arts) has attended the personal hearing on 20.05.2024 and stated that he has completed five year tenure at his present place of posting in Hard Area and has requested for transfer either to GMS, Alathu u/c GSSS, Pairi Distt. Mandi and GSSS, Salwana Distt. Mandi against vacancy.

From the perusal of record, it is found that Sh. Rakesh Kumar, TGT (Arts) is working at GSSS, Cheuni Distt. Mandi (Hard Area) since 18.01.2019 on 1st appointment and has completed five year at his present place of posting. One post of TGT (Arts) is going to vacate at GMS, Alathu u/c GSSS, Pairi District Mandi, due to retirement of present incumbent on 31-05.2024.

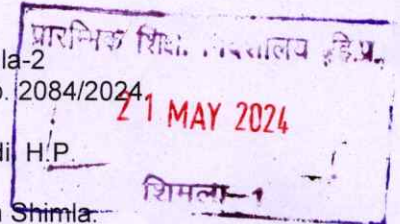
Keeping in view the position stated above, representation of the petitioner i.e Sh. Rakesh Kumar, TGT (Arts) is considered sympathetically and petitioner is hereby transferred from GSSS, Cheuni Distt. Mandi to GMS, Alathu u/c GSSS, Pairi District Mandi against vacancy, caused due to retirement of present incumbent, without TTA/JT. The representation of the petitioner is disposed of accordingly.
